**Burglary in progress - Arrest made of Armed Person**

**Bloomington, IL** - On Sunday, 1/30/2022, at approximately 7:00 a.m., Bloomington officers were dispatched to the 700 block of Douglas St. for a "burglary in progress" call for service. It was reported that a suspect broke into a residence and had since fled the scene. Officers quickly found the suspect, identified as Shaquan Hosea, 26, of Bloomington. As a result of the investigation, Hosea was arrested for: Residential Burglary, Aggravated UWW / Loaded Firearm, and Possession of Cannabis. He was transported to the McLean County Jail.
