The City of Bloomington seeks an accomplished professional with significant entertainment and facilities management experience to lead its newly created Arts & Entertainment Department. The ideal candidate will be ready to cultivate entertainment for and oversee operations of the city's 7,000 seat arena, and the recently restored, city-owned Bloomington Center for the Performing Arts (BCPA) which includes a 1,200-seat auditorium, an 11,000 square foot ballroom and is located in Downtown Bloomington.

Candidate must have an established track record of securing and promoting successful live entertainment events. City leadership sees the bigger economic value to booking quality entertainment vs. measuring by tickets sold giving the selected applicant significant flexibility in setting the strategic plan and vision for both facilities and this newly created department. There is also creative freedom to craft a schedule of events, activities, and other initiatives that will position Bloomington as a regional entertainment hub.

The City is searching for someone with a record of accomplishment in Arena, Stadium, or Performing Arts venue management, and in coordinating large special events or related fields. Candidate should have a bachelor's degree (B.A. / B.S.) from a four-year college or university, with an emphasis on Sports & Entertainment or Stadium Management and at least five (5) years of supervisory experience with a large span of control. An equivalent combination of education and experience may be accepted. Candidate must have strong general management, fiscal and personnel management, leadership skills, and be oriented to the servant leadership model of management. Outstanding interpersonal and communication skills to promote community partnership and engagement throughout the City and the department are a must. Reports to the City Manager. Starting salary \$110,000DOQ.

### Community Background & History




Welcome to Bloomington! A vibrant, growing community nestled in the heart of Central Illinois.

### **Grossinger Motors Arena**

Grossinger Motors Arena opened its doors on April 1, 2006 and has had over 3,000,000 people attend various events over the years. Events held to date include many concerts including Drake, Taylor Swift, Chris Stapleton, and Brad Paisley, family shows, ice shows, motorsports, and trade shows. In addition, the Arena has hosted local high school graduation ceremonies, Chicago Cubs and St. Louis Cardinals caravans, Illinois High School Association's regional and state tournaments, as well as a variety of private meetings and wedding receptions.







### Bloomington Center for the Performing Arts

The Bloomington Center for the Performing Arts is the premier arts and entertainment venue in Central Illinois. Located in the City's downtown, the Bloomington Center for the Performing Arts (BCPA) is a platform for performing arts and entertainment in the community. With a 1,200-seat auditorium and an 11,000 square foot ballroom, the recently restored, historic 1920 theater welcomes more than 40 touring artists annually and is also home to over 20 area performing arts ensembles. The center also features an outdoor summer concert stage.



#### The Role

Sets the strategic plan and vision for the city's entertainment division, curating a schedule of events, activities and other initiatives positioning Bloomington as a regional entertainment hub.

Plans, coordinates and oversees daily operations and activities for the city owned 7,000 seat arena, (previously known as the Grossinger Motors Arena), and the recently restored city owned Bloomington Center for the Performing Arts (BCPA) which includes a 1,200-seat auditorium, an 11,000 square foot ballroom and is located within the Downtown Bloomington Cultural District.

Works with talent buying agencies to bring in entertainment to the region, when necessary.

Cultivates partnerships with existing long-standing venues, new locations and the arts community to elevate what is a burgeoning local entertainment scene

Leads, supervises, advises and coaches managers monitoring and evaluating their performance against both operational and developmental goals. Develops and implements procedures and controls to promote communication and adequate information flow within the department and amongst other departments.

Oversees collection of revenues and spending for annual operating budget and capital budget and communicates to City Manager any variances from projected revenue and budget. Responsible for obtaining and overseeing sponsorships, risk management and financial controls, pursuant to City policies. Responsible for oversight of cash handling procedures, payroll and accounts payable as designated by the City.

In consultation with the Legal department, contracts with entities wishing to rent the Bloomington Arena, Bloomington Center for Performing Arts and other City entertainment facilities. Monitors contractual obligations between department and other agencies or businesses, including collective bargaining agreements. Works collaboratively with representatives of bargaining units to maintain positive working relationships between City and staff.

Creates and maintains a brand image standard for each venue including brand identity, website, social media and advertising. Ensures a calendar of events is maintained and shared with all marketing personnel, the Bloomington-Normal Convention and Visitors Bureau, and all event staff.

- Bachelor's degree with coursework in Sports & Entertainment or Stadium Management, Economic Development, Business Management,
- Public Relations, Marketing, Public Administration or other-related field or a combination of education and relevant experience.;
- Minimum 5 years of experience in Arena, Stadium, or Performing Arts venue management, coordinating large special events, or related field
- At least 5 years of supervisory experience, with a large span of control
- Equivalent combination of education and experience may be accepted
