Updated Release for Armed Robbery/Shots Fired

Bloomington, IL - On 06/03/2022, a McLean County Warrant was issued for the arrest of Terrance Jones. On 06/05/22, Terrance was arrested by the Posen Police department for his involvement in the armed robbery occurring on 5/18/22. Bloomington Police are still asking for the public's assistance in locating the second suspect as the investigation is still ongoing.

Arrested was Terrance Jones, 34, of Chicago Illinois for:

ARMED ROBBERY / DISCHARGED FIREARM
AGG BATTERY/GREAT BODILY HARM
FELON POSSESS WEAPON/2ND+
UNLAWFUL USE OF WEAPONS / FELON POSSESS / USE WEAPON / FIREARM

Jones was transported to the McLean County jail. At the time of this release, Jones' bond is currently set at \$750,000 bond - 10 percent applies.

All suspect(s) are presumed innocent unless proven guilty in the court of law.

Previous Release:

On Wednesday, 5/18/2022, at approximately 2:38 p.m., Bloomington police officers were dispatched to a business in the 2000 block of Ireland Grove Road for a hold up alarm. Upon arrival, officers learned an employee had been battered during an armed robbery. As the investigation continued, officers located other evidence indicating shots were fired inside the business.

There is believed to be two suspects. The suspects appear to be black or Hispanic males, in their twenties. During the incident, both were wearing masks. One suspect was wearing a yellow traffic style vest, the other was wearing a blue vest with white lines. They left the scene in a black four door car, with silver rims, and chrome trim around the windows.
